

To maintain your credential, recertify every 2 years by listing 24 CEUs on the CEU Submission Form, following this document as your guide. **The good-through date on your certification wallet card indicates when the CEU Submission form is due with the \$100 recertification fee.** Keep attendance documentation on file in case of a random recertification audit. Educ2	College/University courses and/or College/University-sponsored distance or online learning. Subject areas in business management or horticulture only.	15 CEUs per credit hour
	<i>Keep proof of completion (certificate or transcript) on file.</i>	
Educ3	Education supporting green industry license completion or renewal—contractor license, pesticide applicator license. Requirements vary by state.	1 CEU per hour of instruction
	<i>Keep proof of completion or CEU statement on file.</i>	
Educ4	Successful completion of additional NALP certification or specialty endorsement.	8 CEUs: earning new certification; 4 CEUs: earning new specialty
	Examples: Landscape Industry Certified Technician - Exterior who earns Landscape Industry Certified Manager gets 8 CEUs	
	<i>No documentation required. NALP will verify.</i>	
Educ5	Writing articles or books for publication, preparing presentations at schools, conferences, workshop or programs, or reading as part of self-study. Subject matter must be green industry or job related. Each article, presentation and self-study material may be counted only once during a two-year recertification period. For CEUs awarded for actual presentation, see Serv4 category.	1 CEU per hour of course preparation, reading time, or 1 CEU per article or 10 CEUs per book published

Serv3	Official ICC auditor/evaluator to Landscape Industry Certified Technician-Exterior exam.	.5 CEU per hour on site

Serv4	Teaching or presenting at schools, professional conferences, workshop or programs. Subject matter must be green industry or job related. For CEUs awarded for preparation of presentation, see Educ5 category.	1 CEU per hour
